

**Information clause in the registration process  
for the "12th International Days of Physiotherapy" Conference**

To fulfill the information obligation resulting from the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons concerning the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (OJ EU L. of 2016, No. 119, p. 1, as amended), hereinafter referred to as "GDPR", we would like to inform you that:

- 1) The controller of personal data is the Wroclaw University of Health and Sport Sciences, with its registered office at al. Ignacego Jana Paderewskiego 35, 51-612 Wroclaw.
- 2) The Administrator has appointed a data protection officer whom you can contact in all matters related to the processing of your personal data by e-mail at the following address: [iod@awf.wroc.pl](mailto:iod@awf.wroc.pl) or by writing to the address indicated in point 1.
- 3) The Administrator will process personal data provided in the registration form (name and surname, affiliation, e-mail address, telephone number) for the purpose of registering for the "XII International Days of Physiotherapy ..." Conference (hereinafter referred to as the "Conference") and for further contact, verification of attendance, sending materials regarding the Conference, etc.
- 4) Your personal data will be processed based on the legitimate interest of the Controller (Article 6 paragraph 1 letter f) of the GDPR, which is the implementation of statutory activities, including the dissemination of knowledge, for statistical purposes and the possible pursuit of claims.
- 5) If you consent to the processing of personal data for the purpose of sending information about other activities of the Wroclaw University of Health and Sport Sciences, in particular, the organization of subsequent editions or other conferences, meetings, etc., personal data in the form of name, surname and e-mail address will be processed for the purpose of sending such information based on your consent (Article 6, paragraph 1, letter a) of the GDPR).
- 6) Your personal data may be transferred to authorized employees of the Controller and other entities closely related to the organization of the conference, such as institutions co-organizing and co-financing the conference (ensuring appropriate measures to protect the personal data collected by us).
- 7) Providing personal data is voluntary, but necessary for successful registration for the Conference. Failure to provide data will result in the inability to participate in the Conference.
- 8) Your personal data will be stored:
  - a) for the time necessary to conduct the Conference, in the case of registration and participation in the Conference,
  - b) until the date of withdrawal of consent, in the case of consent to sending information about the activities of the Wroclaw University of Health and Sport Sciences.
- 9) You have the right to request access to your data, rectification, restriction of processing, deletion, objection, and data transfer, as well as the right to complain with the President of the Personal Data Protection Office in the event of a breach of the personal data protection principles.
- 10) You have the right to withdraw your consent to the processing of your personal data at any time. Withdrawal of consent will not affect any processing based on your consent before its withdrawal.
